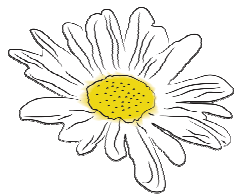


Exhibitor Contract

I understand and agree to the following terms and conditions:

Exhibitor Package A – 8x10 booth with pipe and drape, 1 skirted table, 2 chairs, 1 sign for the booth, database on CD of all bride-to-be entrants at the end of the show, 2 lunch tickets

Exhibitor Package B – 8x10 space without pipe and drape on the concourse, 1 skirted table, 2 chairs, 1 sign for the booth, database on CD of all bride-to-be entrants at the end of the show, 2 lunch tickets

Exhibitor Package C - 6x10 space without pipe and drape on the concourse, 1 skirted table, 2 chairs, 1 sign for the booth, database on CD of all bride-to-be entrants at the end of the show, 2 lunch tickets

Booths are reserved on receiving payment and a signed contract making it first come first served. Lower price booths go quickly. If at the time your contract is received they are gone, you will be given the opportunity to upgrade.

For very new (less than a year in business) and very small exhibitors (like pastors, calligraphers as examples) with QCWeddings.com pre-approval it is possible to be granted permission for two vendors to share expenses. A contract will be required from both and each must have their payment accompany the contract.

Setup is from the loading docks at Quad Cities Watermark Convention Center starting at 6:00am the day of the show, September 20th, 2009. Teardown begins at 5:00pm and not before. Setup begins at 6:00am and ends at 11:45am.

Pre-registered first 100 people will have a special showing from noon until 1:00pm. This showing will be focused in the front lobby. A wine tasting, finger foods, cake and chocolate fountain are being discussed and arranged. Dinner music will be provided by one of our Entertainment Companies. These 100 guests will also be granted entrance to the show before the official 1:00 pm show.

Lunch for all exhibitors will begin at 11:00 am and continue through 1:00pm. 2 Tickets each booth will be issued during setup. We are arranging for the hosting facility to set up a booth space to sell coffee, water, pop, and some snacks throughout the day.

Exhibitor must request electricity from Isle Corp Casino Hotel Bettendorf. A separate form is provided. There is a fee for electricity separate from your booth fee.

Exhibitor may request different table arrangements from Isle Corp Casino Hotel Bettendorf. A separate form is provided. There is a fee for different tables and additional tables for your booth.

No open flame permitted in any space occupied by an exhibitor. It must be seated in such a way it is not easily knocked over and it must be inside a container. Candle sticks, pillars, and torches are not permitted to have a lit flame.

Exhibitors are expected to remain in their allotted booth space paying attention to not extend display or vendors standing in the allotted walkways.

Every exhibitor remains fully responsible for any loss, costs, damages and expenses occasioned by any accident or occurrence causing harm to any person on or around the leased premises. Every exhibitor remains fully responsible for any damage by the exhibitor or their employee to the leased property (Quad Cities Watermark Convention Center) specifically in the area of their booth space.
